Dear Madam, Dear Sir,

Pursuant to the mission which was entrusted to us by your liaison bureau, we present our report on the fiscal year closed on 31 December 2011, including:

- The control of the annual statements of the Association, as attached to this report;

The annual statements were closed by the President. We have to give an opinion on these accounts, based on our audit.

1. Opinion on the yearly statements
