

3 countries have basin committees

Workshop on participatory management (with NGOs, local authorities)

2 consultation phases: 2019 et 2020

Dissemination and accessibility of information

**Awareness actions** (young people and rural populations). Awareness campaign carried out in Armenia with schoolchildren (2 basins, 30 schools, around 350 children).



Training of teachers to conduct an awareness campaign on water quality with their students (June 2019)

Hydrographic regions


Water Law of January 8, 1997 which establishes the national water resources policy

Art.1 ° The national water resources policy is based on the following fundamental principles:


...

VI - The management of water resources must be decentralized and rely on the participation of the public authorities, users and communities.
