Paris Pact on water and adaptation to climate change in the basins of rivers, lakes and aquifers

At the twenty-first Conference of the Parties to the United Nations Framework Convention on Climate Change (COP21 / CMP11) organized from 30 November to 11 December 2015 in Paris, We, representatives of governments, international organizations, donors, national and transboundary basin organizations of rivers, lakes or aquifers, local authorities, of the civil society and companies, support the integration of Water into the Climate change Action Agenda, especially for initiating or strengthening necessary adaptation actions in the basins of rivers, lakes, aquifers and large wetlands.

GENERAL STATEMENT

Climate change is already affecting and will increasingly affect the quantity and quality of freshwater and aquatic ecosystems, especially through the intensity and greater frequency of extreme hydrological events, such as floods and droughts, as well as the increase in ocean level, which threaten security, economic and social development and the environment.

We recognize that adaptation actions should be undertaken without delay to minimize the impacts of climate change on the populations' health and safety, on economic development and the environment, considering the importance of the protection of water-related ecosystems.

The basins are natural areas where water flows on the surface and in the subsoil: they are the relevant territories for organizing water resources management.

In order to ensure more effectiveness, these actions to adapt to climate change should thus be implemented at the level of river, lake and aquifer basins, through a joint, participative, integrated and sustainable water resources management.

We should act quickly before it is too late!

To that end, mobilizing new and increasing funding dedicated to climate change adaptation in basins is essential. Therefore, new basin organizations and existing ones should be financed and strengthened to facilitate the cooperation, coordination and exchange of information, dialogue, consultation and prevention of conflicts between stakeholders and to enhance the implementation of adaptation measures and the sharing of benefits on the basin scale,

We encourage donors to support prior assessments and actions for adaptation to climate change in basins,

Local authorities and communities, economic sectors and the civil society should be better associated and involved in basin management, including in the definition and implementation of adaptation measures.

Cooperation and exchange should increase between the institutions involved, especially among the basin organizations at the global and regional levels in order to facilitate the transfer of experience and know-how on best practices in basin management and adaptation to climate change.









Twinning between Basins Organizations

Spain - Italy



Twinning between the Júcar and Arno Basin Authorities

The Júcar River Basin Authority (JRBA) has been since 1934 an autonomous organization with a wide experience regarding integrated water resources management gained in several decades.

In past years, the JRBA realized twinning agreements with other river basin organizations from countries in Europe (Greece, Romania and Bulgaria), Central Asia (Uzbekistan) and Africa (Morocco); some of those in the context of the **Twinbasin Project** (2007), with the support of the Mediterranean Network of Basin Organizations (MENBO).

Following first contacts during the 8th EUROPE-INBO Conference in Mégève (2010), the JRBA has signed a twinning agreement with the **Authority of the Arno River Basin (Italy)**.

The hydrological characteristics of the Arno and Júcar River Basins are similar.

Both river basin organizations collaborated during one year (2011-12), working on the technical aspects of the implementation of the Water Framework and Flood Directives. During the World Water Forum, the JRBA presented a comparative analysis on the state of compliance with the Good Status goals for Water Bodies to be fulfilled by 2015 in several Euro-Mediterranean river basins: Júcar, Duero (Spain), Arno (Italy) and all the French basins.

The experience of the twinning has been satisfying and interesting for the involved parties. Both organizations depending on the national central administration, count on similar management organs and instruments.



However, the methodology used by each country to implement the European directives depends on the internal administrative structure of each Member State, which sometimes made difficult a real comparison of the proposed works during the twinning, especially

regarding the economic analysis, cost recovery, program of measures and its financing.

La lettre du RIOB

Adaptation au changement climatique : "Une gestion intégrée par bassin est décisive pour assurer la pérennité des ressources en eau"

Les Ministres présents au 7^{me} Forum Mondial de l'Eau, par cette déclaration officielle, ont reconnu l'importance cruciale d'une approche par bassin pour faire face aux pressions qui subissent les ressources en eau douce et qui vont s'exacerber avec la croissance démographique et les effets du changement climatique.

Que les bassins soient nationaux ou transfrontaliers, le changement climatique va se traduire rapidement, si ce n'est pas déjà le cas, par une modification sensible des cycles hydrographiques et une intensification des phénomènes extrêmes d'inondation et de sécheresse ; il faut réagir très vite, avant qu'il ne soit trop tard, et prendre d'urgence les mesures d'adaptation qui s'imposent pour assurer une gestion pérenne des ressources en eau partout dans le Monde.

Dans le contexte de la préparation de la COP21, la grande conférence mondiale sur le climat qui se tiendra à Paris, en France, à la fin de cette année, le Réseau International des Organismes de Bassin (RIOB), fort d'une expérience et d'une expertise acquise depuis plusieurs années, veut apporter sa contribution par des actions concrètes d'ores et déjà engagées par ses Organismes-Membres.

Dès janvier 2010, la déclaration finale de notre Assemblée Générale Mondiale de Dakar avait donné l'alerte sur le risque que l'eau douce soit "une des toutes premières victimes du changement climatique" et proposé des premières mesures à prendre d'urgence et la nécessité de renforcer la solidarité amont-aval à l'échelle des bassins de tous les grands fleuves du Monde.

La CEE-ONU et le RIOB animent une plate-forme de bassins pilotes pour tester et promouvoir des mesures efficaces d'adaptation aux effets du changement climatique sur les ressources en eau, parmi lesquelles des "Mesures de Rétention Naturelle des Eaux", inventoriées avec l'appui de la Commission Européenne, qui apparaissent comme immédiatement applicables.

Ces travaux viennent de déboucher sur la publication conjointement par les Nations Unies et le RIOB d'un recueil de bonnes pratiques et de recommandations pour l'adaptation au changement climatique dans les bassins transfrontaliers, présenté durant une journée Interfélonale sur l'adaptation au changement climatique dans les bassins au Forum Mondial de l'Eau de Côte.

Le RIOB et le RELOB animent avec l'OIEau le projet "ECO-CUENCA", financé par l'Union Européenne dans le cadre du programme "WaterClimate" pour l'Amérique Latine et les Caraïbes.

Le RIOB soutient également la création de Systèmes d'Information sur l'Eau (SIE), qui sont indispensables pour évaluer l'état des lieux dans les bassins et suivre les évolutions. Mais il faut aller beaucoup plus loin et lancer une mobilisation générale en faveur de l'eau douce ; c'est pourquoi, le RIOB propose à ses Membres, dans le cadre de la COP 21, de s'engager à inscrire des mesures d'adaptation reconnues comme réalisables rapidement dans leurs "Plans de Gestion de Bassin".

La mobilisation de tous est indispensable !!
