## Objective and scope of the call

This call seeks to support the implementation of the [OECD Principles on Water Governance](#) through the identification of evolving practices at local, basin, national and international levels which can inspire governments and stakeholders move from vision to action. The Principles provide standards for governments to design and implement effective, efficient, and inclusive water policies whilst sharing this responsibility with a broader range of stakeholders. They were developed using a multi-stakeholder approach within the framework of the [OECD Water Governance Initiative](#), adopted by all OECD Member countries in 2015, and endorsed by 140 stakeholders from public, private and non-profit sectors gathered under the umbrella of the [Global Coalition for Good Water Governance](#).

The objective is to gather/compile evidence and concrete examples of how a given city, region, country, basin organisation or other stakeholder has addressed governance gaps in water-related policy design and implementation, whether they relate to success stories or, conversely, to failed attempts from which helpful lessons can be learned for the future.

Practices submitted for consideration can cover a **broad range of topics or countries**; in particular they can :

- relate to any of the water-related **sub-sectors** (services, resources, flood, environment, etc.);
- target any **scale** of governance (local, basin, regional, national or global);
- concern any **category** of stakeholders (government, citizens, service providers, regulators, etc.); and
- be from an **OECD and non-OECD** country.

Practices submitted for consideration must adhere to the following **minimum criteria**:

- be relevant for **at least** one of the **OECD Principles on Water Governance**;
- refer to the implementation and/or design of i) a **policy making process**; ii) a **governance instrument**; or iii) any other process leading to **tangible impacts** in terms of improvement of water management outcomes;
- be **result-oriented** and highlight the potential for **replicability**;
- show substantial **progress** from a specified baseline towards (but not necessarily reaching) full implementation. Practices can also be ongoing “narratives” of collective learning.

## Selection, peer reviewing and dissemination of practices

Practices will be selected and peer reviewed by the members of the OECD Water Governance Initiative, on the basis of information submitted in this form. In particular, selection criteria will consider whether the practice provides :

- Sufficient evidence of **implementation** (completed or ongoing);
- Sufficient evidence of **assessment** of the effectiveness, success, results of the practice;
- Sufficient evidence of **replicability** (capacity to be adapted in part or in full to other contexts and places);
- Special attention will be given to practices that emphasise lessons learned from **failed attempts**;

Selected practices could be disseminated through one or several of the following channels:

- Presentations and discussions at the bi-annual plenary meetings of the **Water Governance Initiative**
- Dedicated “snapshots” in the OECD “**Water Governance at a Glance**” report to be released in 2018
- Presentations during the OECD-led governance sessions at the **8<sup>th</sup> World Water Forum** (Brasilia, 2018)
- Spotlight in the **OECD Online Database on Water Governance** to be launched in 2018.

### How to fill in the form

The form comprises 3 sections, which have to be comprehensively filled in:

- **Profile of your practice** with key descriptions (who, what, when, why and where).
- **Linking your practice** to OECD Principles on Water Governance, to illustrate them in part or in full.
- **Assessment of your practice** in terms of costs and benefits, progress and replicability potential.

Practice providers are kindly requested to:

- Provide their **contact details** for follow-up, particularly during the peer-review;
- Submit the practice on behalf of their **organisation**;
- Coordinate with **stakeholders** involved in the practice within or outside their organisation;
- **Answer all questions** of the template in English, French or Spanish;
- Provide relevant **sources and weblinks** for the future inclusion in the database, which will *not* be processed for the peer-review or selection of the practice;

### Basic definitions used in this form

- **Water Governance** encompasses rules and practices as well as political, institutional, and administrative processes through which stakeholders articulate their interests, their concerns are considered, decisions are taken and implemented, and decision-makers are held accountable in the development and management of water resources and delivery of water services.
- **Stakeholder**: any person or group who has an interest or stake in the topic, may be directly or indirectly affected by water policy, and/or have the ability to influence the outcome, either positively or negatively
- **Scale for water management** refers to the multitude geographical and administrative units that are relevant for the management of water resources and water services at catchment, city, basin, regional, national, transboundary or global levels.
